DIRECTORS' REPORT & MANAGEMENT DISCUSSION AND ANALYSIS

Dear Shareholders,

We have pleasure in presenting the Sixteenth Annual Report of the Company together with the Audited Statement of Accounts for the year ended 31st March 2016.

STATE OF THE COMPANY'S AFFAIRS

During the period under review, the Company has earned revenue of Rs.9302.03 lakhs and Net Loss of Rs.69.65 lakhs.

PERFORMANCE OF THE COMPANY

The Company is mainly engaged in manufacturing and marketing of readymade garments in the domestic market under the brand name of Trigger, export of readymade garments and manufacturing of readymade garments for other domestic brands

The profitability for the year was affected on account of lower sales realization.

CONSOLIDATED FINANCIAL STATEMENTS

There are no subsidiaries, associates or joint ventures for the Company. Hence the provision of Section 129(3) read with rule 5 are not applicable for the Company.

Report on the Financial Statements

We have audited the accompanying financial statements of **TRIGGER APPARELS LIMITED** (“the Company”), which comprise the Balance Sheet as at 31st March, 2016, the Statement of Profit and Loss and Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in Section 134(5) of the Companies Act, 2013 (“the Act”) with respect to the preparation and presentation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014.
